Stephanie Anthony Geneva, Illinois

Stephanie E. Anthony is a teaching elder who serves as the pastor and head of staff of Fox Valley Presbyterian Church in Geneva, Illinois. He served as co-chair of the A Corp. Board from 2018 through 2021.

Chris is a partner in the law firm of Nixon Peabody LLP, where he holds and has held various leadership positions, including as a member for six years of the firm's board, a member since its inception of the firm's Pro Bono Committee, deputy head of the firm's Class Action Team, and head of the firm's Arbitration Team. He has been appointed by New York state and federal courts as a mediator in numerous cases over the past 20 years and was recently selected for the Mediation Advisory Committee for the United States District Court for the Southern District of New York.
